



Main Motion E | Regional Advisor Qualifications

Whereas, the position of Regional Advisor is mainly intended to support the Regional Board of Directors and be a resource to member school advisors; and,

Whereas, this position is held by a professional staff member and three years of professional working experience may limit the pool of interested and eligible advisors; and,

Whereas, current eligibility standards limit the candidate pool.

Therefore let it be resolved, that the Regional Advisor qualifications will be changed to a 2 years of professional working experience, and conference experience are more varied; and,

Therefore let it further be resolved, Article X be amended as follows:

ARTICLE X	REGIONAL BOARD OF DIRECTORS
<p><u>Section 7</u></p>	<p>Regional Advisor Qualifications</p> <ul style="list-style-type: none"> A. The Regional Advisor shall be a member of the professional housing community from a member school in good standing. B. Regional Advisor must be employed in a full-time student personnel position with at least 2 3 years of full-time professional experience in housing and/or residence life. <ul style="list-style-type: none"> a. <u>Full-time professional experience is considered that experience which has been completed while in a professional role, not including time as a Graduate Assistant.</u> C. Must have previous RHA or NRHH advising experience. D. The Regional Advisor must have been previously inducted into the National Residence Hall Honorary, must have advised an NRHH chapter previously, must have completed NRHH training through ART, or be approved by a vote in the NRHH boardroom. E. It is preferred, but not required, that the Regional Advisor have completed the ART program and have been grandfathered into the current ART curriculum or have completed level one and level two of the current ART curriculum. F. Must have attended at least one NACURH and one regional conference and have been present in boardroom. <u>two of the following conferences in any combination, and been present in boardroom:</u> <ul style="list-style-type: none"> a. <u>Regional Leadership Conference</u> b. <u>Regional Business Conference</u> c. <u>NACURH Annual Conference</u> d. <u>NACURH Semi-Annual Conference</u>
<p><u>Section 8</u></p>	<p>RBD Term of Office</p> <ul style="list-style-type: none"> A. The incoming members of the RBD elected/confirmed at the Regional Business Conference will be considered position-elects from the time they are elected/confirmed until the close of the proceeding NACURH Conference.

	<ul style="list-style-type: none">B. The term of office for all members of the RBD shall be for one year from the close of the annual NACURH Conference to the close of the following annual NACURH Conference.C. The term of office of the Regional Advisor shall be from the annual NACURH Conference following confirmation to the annual NACURH Conference three years after.D. Selection of the Advisor will occur every three years via the process and timeline outlined in this section.
